9. To receive Councillor Reports and Agenda items for next meeting

Concerns from residents had been raised about the parking of guests using Greenhouse and the necessity for them to park close to the wall. More signage needed to be erected to inform residents. There had been issues with access which is causing the Village Green to be eroded. This parking issue also causes problems for emergency vehicles.

There were two other properties which were on occasion blocking the access road around the Green. The Clerk was asked to write a letter to each householder to ask them to refrain from parking in the access road.

The tubs on the green would be planted with red, white and blue in preparation of the King's Coronation.

Flytipping was still occurring along Topps Hill Road and this was concerning. It was thought that this issue had been dealt with directly and with NNDC however, it appeared the problem had recommenced. It was agreed that the situation would be monitored and photographic evidence gathered to address this matter again.

A review of the poles may need to take place however, all Councillors were aware of their responsibility to protect the Village Green.
